

**TOWN OF JEFFERSON
ORDINANCE 09-13**

**USE OF TOWN OF JEFFERSON ROADS, JEFFERSON COUNTY, WI
BY JEFFERSON ½ MILE ATV CLUB
TO CONNECT PRIVATE TRAILS**

Approve use of Town of Jefferson roads by The Jefferson ½ Mile ATV Club
To connect to The Jefferson ½ Mile ATV Club's private trails

SECTION 1: APPLICABILITY:

Pursuant to the Town's authority under section 1.1.01 as authorized by 23.33 (8) (b), Wisconsin Statutes, this ordinance establishes specific Town roads for use by The Jefferson ½ Mile ATV Club as connectors to the club's private trails. Those Town roads (or portions) are:

- A. Ambrose Lane
- B. North Schopen Road
- C. South Schopen Road
- D. F and J Townline Road (south side);

SECTION II: PROVISIONS AND CONDITIONS:

The applicable provisions of 23.33 Wis. Stats., regulating ATV operation pursuant to routes are adopted, and The Jefferson ½ Mile ATV Club agrees to the following conditions:

- A. Ask for Town Board approval of any and all Town Road usage;
- B. Provide proper paperwork, including a current Certificate of Liability Insurance;
- C. Post approved roads (at the Town's direction) according to DOT/DNR.

SECTION III: ENFORCEMENT AND PENALTIES:

This ordinance shall be enforced by any law enforcement officer authorized to enforce the laws of the state of Wisconsin; subject to Wisconsin State All-Terrain Vehicle penalties as found in s. 23.33 (13) (a) Wis. Stats., and are adopted by reference.

SECTION IV: EFFECTIVE DATE:

This ordinance shall take effect immediately upon passage and posting or publication as provided by law.

The foregoing ordinance was adopted at a regular meeting of the Town Board of Jefferson, Jefferson County, Wisconsin, on September 5, 2013.
