**NOTICE OF HEARING – VACATE AND DISCONTINUE A PORTION OF RIVER ROAD RIGHT OF**  
**WAY IN THE TOWN OF JEFFERSON**

A public hearing will be held by the Town Board of the Town of Jefferson at the Town Meeting Hall, St Coletta Cabin, 434 County Road Y Jefferson, WI 53549 on Thursday, December 17, 2020, at 5:00 PM to discuss a proposed action to commence vacation of a portion of river road right of way of the following described by introduction of *Resolution 11-20A, Resolution of the Town Board of the Town of Jefferson To Vacate and Discontinue a Portion of River Road Right of Way*, under Sec. 66.1003, Wis. Stats., specifically:

Vacated Right of Way Part of Government Lot 1 in Section 23, T6N, R14E, Town of Jefferson, Jefferson County Wisconsin to wit:

Commencing at a 4" diameter aluminum monument at the NE corner of said Section 23; thence N88<sup>0</sup>06'33"W, along the north line of said Government Lot 1, 1626.57 feet; thence S3<sup>0</sup>22'20"W, 765.30 feet to a 1 ½ inch iron pipe at the NE corner of existing right of way and the point of beginning; thence continue S3<sup>0</sup>22'20"W, along the westerly line of Riverside Lane, 49.50 feet to a ¾ iron rod; thence N87<sup>0</sup>06'52"W, 192.60 feet to a 1 ½ iron rod meander corner which is S87<sup>0</sup>06'52"E, 32 feet more or less from the Rock River, thence North to a point S87<sup>0</sup>05'49"E, 208.37 feet from point of beginning, to a 1 ½" iron rod meander corner which is S87<sup>0</sup>05'49"E, 4 feet more or less from the Rock River, thence N87<sup>0</sup>05'49"E, 208.37 feet to the point of beginning, including all lands between the described meander line, the courses, S87<sup>0</sup>05'49"E, 4 feet more or less, S87<sup>0</sup>06'52"E, 32 feet more or less and the Rock River.
